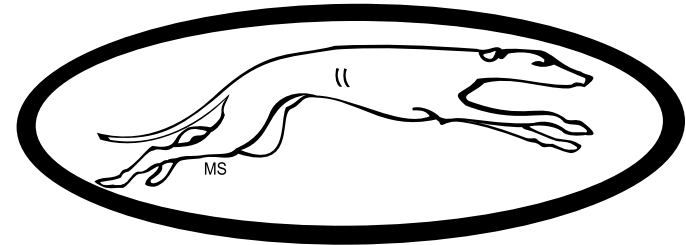

## ELIGIBLE BREEDS & REGISTRY

ONLY PURE BRED AFGHAN HOUNDS, AZAWAKHS, BASENJIS, BORZOI, CIRNECO DELL'ETNA GREYHOUNDS, IBIZAN HOUNDS, IRISH WOLFHOUNDS, ITALIAN GREYHOUNDS, PHAROAH HOUNDS, RHODESIAN RIDGEBACKS, SALUKIS, SCOTTISH DEERHOUNDS, SLOUGHIS AND WHIPPETS MAY BE ENTERED IN THE REGULAR STAKES. ALL ENTRIES SHALL BE INDIVIDUALLY REGISTERED WITH THE AMERICAN KENNEL CLUB, THE GREYHOUND ASSOCIATION, THE FEDERATION CYNOLOGIQUE INTERNATIONALE, AN ASFA RECOGNIZED FOREIGN OR ASFA BOARD APPROVED REGISTRY OR POSSESS A CRITIQUE REGISTRATION NUMBER (CRN) FROM THE SOCIETY FOR THE PERPETUATION OF THE DESERT-BRED SALUKI (SPDBS). LIMITED AND/OR PROVISIONAL STAKES ENTRIES SHALL BE INDIVIDUALLY REGISTERED WITH THE APPROPRIATE REGISTRY. ONLY PUREBRED CIRNECO DELL'ETNA, CHART POLSKI, GALGO ESPANOLS, MAGYARS AGARS, PERUVIAN INCA ORCHID AND PORTUGUESE PODENGA ARE ELIGIBLE FOR ENTRY.

## - STAKES OFFERED -

LIMITED - ANY ELIGIBLE SIGHTHOUND AS DEFINED, ONE YEAR OF AGE OR OLDER ON THE DAY OF THE TRIAL THAT HAS MET ASFA CERTIFICATION REQUIREMENTS.

## BEST IN FIELD WILL NOT BE OFFERED - SEE FLYER

HOUNDS MUST BE ONE YEAR OR OLDER ON THE DAY OF THE TRIAL AND WILL BE EXAMINED FOR BREED DISQUALIFICATIONS - SPAYED, NEUTERED, MONOCHID AND CHRYPTORCHID HOUNDS WITHOUT BREED DISQUALIFICATIONS MAY BE ENTERED

STAKES WILL BE SPLIT INTO FLIGHTS BY PUBLIC RANDOM DRAW IF THE ENTRY IN ANY REGULAR STAKE IS 20 OR MORE. BITCHES IN SEASON, LAME HOUNDS AND HOUNDS WITHOUT BREED DISQUALIFICATIONS MAY BE ENTERED; HOUNDS WITH BREED DISQUALIFICATIONS ARE NOT ELIGIBLE TO ENTER (EXCEPT IN THE SINGLE STAKE). UNLESS EXCUSED, DISMISSED OR DISQUALIFIED. HOUND CERTIFICATION RUNS WILL (OR WILL NOT) BE OFFERED AND WHEN (EXAMPLES: ONE HOUR PRIOR TO ROLL CALL, FOLLOWING THE TRIAL, BEFORE PRACTICES, ETC.

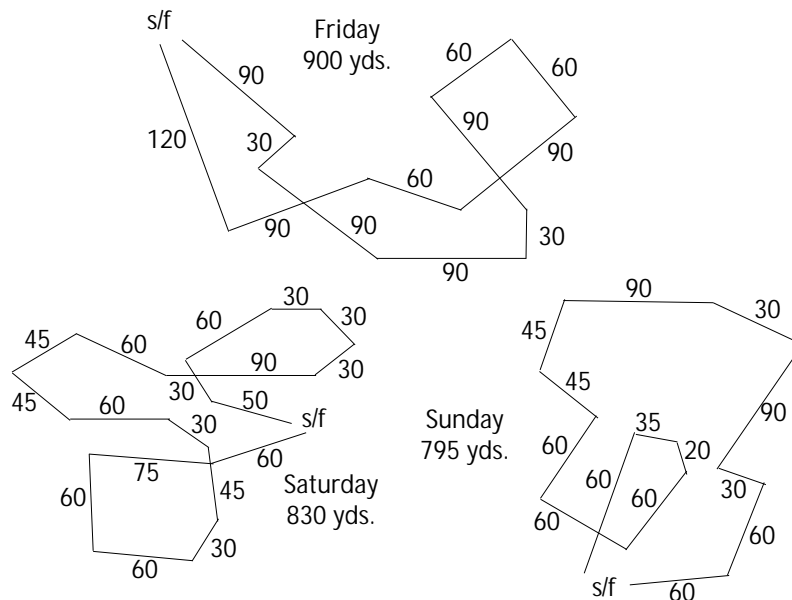
BATTERY POWERED CONTINUOUS LOOP LURE MACHINES WITH BACK-UP EQUIPMENT WILL BE USED. THE LURE WILL CONSIST OF WHITE PLASTIC AND/OR FUR STRIPS.

THE COURSE WILL BE REVERSED FOR FINAL COURSES, REVERSED AGAIN FOR ANY B.O.B., B.I.F. AND TIE RUN-OFFS.

THE CLUB RESERVES THE RIGHT TO ALTER THE COURSE AS REQUIRED BY WEATHER AND/OR FIELD CONDITIONS ON THE DAY OF THE TRIAL.

ALL OWNERS MUST KEEP THEIR HOUNDS UNDER CONTROL AT ALL TIMES AND MUST CLEAN UP AFTER THEM. THERE WILL BE A \$5 FINE ASSESSED FOR ANY LOOSE HOUND ON THE FIELD NOT TAKING PART IN A COURSE IN PROGRESS. THERE WILL BE A \$15 FINE ASSESSED FOR ANY OWNER WHO DOES NOT CLEAN UP AFTER HIS/HER HOUND.
