

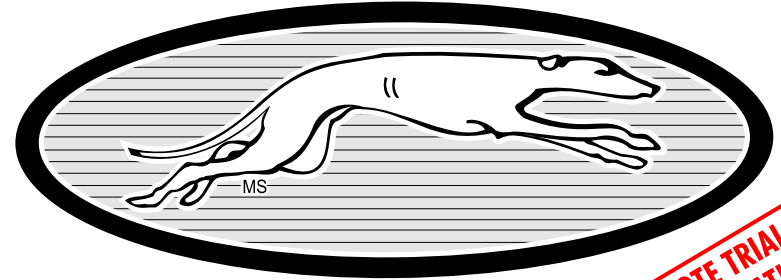

ONLY PUREBRED AFGHAN HOUNDS, AZAWAKHS, BASENjis, BORZOI, CIRNECHI DELL'ETNAS, GREYHOUNDS, IBIZAN HOUNDS, IRISH WOLFHOUNDS, ITALIAN GREYHOUNDS, PHAROAH HOUNDS, RHODESIAN RIDGEBACKS, SALUKIS, SCOTTISH DEERHOUNDS, SLOUGHIS, WHIPPETS AND PROVISIONAL BREEDS, IF ANY MAY BE ENTERED IN THE REGULAR STAKES. LIMITED STAKE BREEDS, IF ANY, ARE ENTERED IN THE LIMITED STAKE AND CURRENTLY INCLUDE PUREBRED CHART POLSKIS, GALGO ESPANOLS, MAGYAR AGARS, PERUVIAN INCA ORCHIDS AND PORTUGUESE PODENGOS. ALL ENTRIES IN THE REGULAR STAKES SHALL BE INDIVIDUALLY REGISTERED WITH THE AMERICAN KENNEL CLUB, THE UNITED KENNEL CLUB, THE NATIONAL GREYHOUND ASSOCIATION, THE FEDERATION CYNOLOGIQUE INTERNATIONALE, AN ASFA-RECOGNIZED FOREIGN OR ASFA BOARD APPROVED REGISTRY, OR POSSESS A CRITIQUE REGISTRATION NUMBER(CRN) FROM THE SOCIETY FOR THE PERPETUATION OF DESERT BRED SALUKIS(SPDBS). - STAKES OFFERED -

OPEN STAKE: ANY ELIGIBLE SIGHTHOUND, EXCLUDING ASFA CHAMPIONS OF RECORD.

FIELD CHAMPION STAKE: ANY ASFA FIELD CHAMPION.

VETERAN STAKE: ANY ELIGIBLE HOUND WHOSE AGE IS AT LEAST SIX YEARS, EXCEPT IRISH WOLFHOUNDS WHOSE AGE SHALL BE AT LEAST FIVE YEARS, AND RIDGEBACKS AND WHIPPETS WHOSE AGE SHALL BE AT LEAST SEVEN YEARS. POINTS AND PLACEMENT GO TOWARD V-FCH & V-LCM TITLES.

LIMITED STAKE: ANY ELIGIBLE SIGHTHOUND OF A LIMITED OR PROVISIONAL STAKE BREED THAT HAS MET CERTIFICATION REQUIREMENTS. NOT ELIGIBLE TO COMPETE IN BEST OF BREED OR BEST IN FIELD.

SINGLE STAKE: ANY ELIGIBLE SIGHTHOUND INCLUDING THOSE DISQUALIFIED TO RUN IN OTHER STAKES. NOT ELIGIBLE TO COMPETE IN BEST OF BREED OR BEST IN FIELD.

CONDITIONS OF ENTRY:

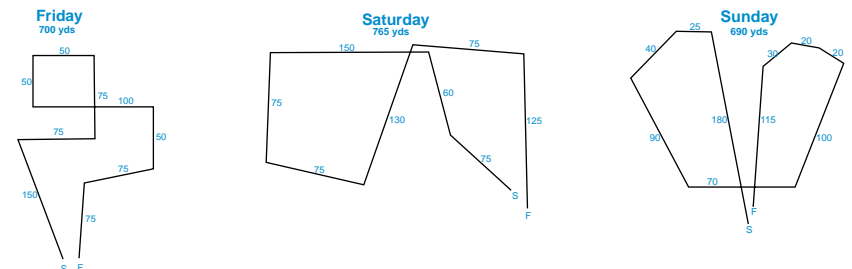
- ALL ENTRIES MUST BE ONE YEAR OR OLDER ON THE DAY OF THE TRIAL.
- STAKES WILL BE SPLIT INTO FLIGHTS BY PUBLIC RANDOM DRAW IF THE ENTRY IN ANY REGULAR STAKE IS 20 OR MORE.
- BITCHES IN SEASON, LAME HOUNDS AND HOUNDS WITH BREED DISQUALIFICATIONS WILL BE EXCUSED AT ROLL CALL.
- SPAYED, NEUTERED, MONORCHID AND CRYPTORCHID HOUNDS WITHOUT BREED DISQUALIFICATIONS MAY BE ENTERED.
- HOUNDS WITH BREED DISQUALIFICATIONS ARE NOT ELIGIBLE TO ENTER EXCEPT IN THE SINGLE STAKES.
- HOUNDS NOT PRESENT AT THE TIME OF ROLL CALL WILL BE SCRATCHED.
- ALL HOUNDS RUN TWICE, IN TRIOS IF POSSIBLE OR BRACES (EXCEPT IN SINGLE STAKE), UNLESS EXCUSED, DISMISSED OR DISQUALIFIED.
